Agriculture Minister Shri Sharad Pawar ditches fishermen - Ram Naik

Mumbai, Monday: "To sanction rebate of Rs.4 per litre of diesel to fishermen, to provide loan at 4 percent interest and to pass a suitable legislation to ensure law and order beyond 12 nautical miles in sea were the three demands of fishermen which were assured to be considered positively by Agriculture Minister Shri Sharad Pawar in a meeting held on 26th April 2012. However instead of taking positive decisions, Shri Sharad Pawar has ditched the coastal fishermen. The fishermen will now launch an agitation", warned Shri Ram Naik, Bharatiya Janata Party leader and former Petroleum Minister in a press conference held to-day in Mumbai. Shri Rajendra Meher, Convener, BJP Maharashtra Fishermen Cell and Shri Sagar Killekar, Convener, Mumbai Cell were also present in the conference.

While explaining the problems of fishermen, Shri Ram Naik said, "Taking into consideration the rise of diesel prices, we had demanded in a meeting held on 26th April 2012 in Delhi to increase the rebate on diesel to Rs. 4 per litre and also to withdraw the condition that rebate was available only to fishermen below poverty line (BPL). We had explained that fishermen owning a fishing boat can never be a BPL. Moreover the budget for 2012-2013 had provided that farmers would get loans at 7 percent with a provision that those repaying installments within time would get a rebate of 3 percent, resulting into an effective rate of 4 percent. Since fishing is also considered as 'farming on water', we had demanded that fishermen should also get loan at 4 percent. We had also demanded a suitable legislation for

maintaining law and order in the Exclusive Economic Zone (EEZ) as there have

been frequent attacks on the fishermen fishing beyond 12 nautical miles. The

Agriculture Minister had assured that the proposed Bill is under consideration."

"Agriculture Minister Shri Pawar had promised that the Government would

consider all the three issues positively. Since there was no communication form

him, we sent a reminder. We have now received his letter dated 21st September

which says subsidy would be provided only to BPL fishermen. Regarding the rate

of interest, the matter would be proposed for incorporation in the revised schemes

for 12th plan'. About the issue of regulating fishing in EEZ, the Ministry 'is still in

the process of finalising a draft Bill'. The substance is that no positive decision has

been taken, leave aside the implementation. We are in dialogue with the

Agriculture Minister from 2007, however the UPA government has not given any

relief to the fishermen. Agriculture Minister Shri Sharad Pawar has thus ditched

the fishermen. We have therefore decided to launch an agitation against the

inactive, in sensitive and anti-fishermen UPA government", stated Shri Ram Naik

at the end.

I have got the issues contained in your letter examined. Regarding the issue of regulating fishing in EEZ, the Ministry of Agriculture is in the process of finalizing a draft Bill for the purpose. As regards the diesel subsidy, during 11th Plan the subsidy was enhanced to ₹3 per litre being provided only to the fishers of BPL category. Regarding the issue of interest subvention on the loan taken by fishermen, the matter would be proposed for incorporation in the revised schemes for 12th plan.
